*The Examiner and the Customer agree to the following terms and conditions:*

1. Jordan Driving School of the Carolinas Inc. is licensed to conduct road tests by the State of North Carolina Division of Motor Vehicles. Under this agreement, Jordan Driving School of the Carolinas Inc. may not provide road tests to more than one customer at a time.
2. Dates and times for the Road Test will be given to the Customer in advance and adhered. In the event of unforeseen contingencies, the Examiner may make changes as far in advance as possible (no less than 24-hour notice) and all parties notified by telephone or in-person. The Examiner requires 24-hours' notice by the Customer to cancel a scheduled appointment.
3. Any unsuccessful test taker must wait a minimum of 48 hours before retaking the test.
4. This contract is valid for one road test. Any subsequent road tests will require a separate contract under the same terms.
5. This contract constitutes the entire agreement between the Customer and the Examiner. Verbal assurances or promises not contained herein are not binding in any way on the Examiner or the Customer.
6. In the operation of a JDS of the Carolinas Inc. motor vehicle, there are certain hazards and risks. The Customer does hereby specifically assume all such risks as may be incurred in the normal operation of a motor vehicle during course of instruction. Each Examiner vehicle is fully insured with liability coverage in the amount of \$100,000/\$300,000/\$50,000. The Customer agrees to completely release the Examiner and its associates from any liability and all claims or courses of action resulting and arising from damages or injuries suffered by the Customer during this course to the extent that claims shall not be covered by the Examiner insurance coverage.
7. The Customer confirms that they meet the below requirements to be eligible for the Road Test;
  - a. Has a Valid NC Permit in their possession, with a physical card that will be on their person at the time of the road test.
  - b. Does not have Restrictions other than '0' for 'None' or '1' for 'Corrective Lenses' listed on their permit.
